## EXHIBIT 1 GENERAL REQUIREMENTS

### (a) Project Description

The proposed Facility is a utility-scale wind energy generating project located in Madison County, New York with a generating capacity of up to 100 megawatts (MW). The Facility will include up to 24 wind turbines, with 12 located in the Town of Fenner, three in the Town of Smithfield, one in the Town of Nelson, and eight in the Town of Eaton. Associated support facilities will include an underground medium voltage collection system, gravel access roads, a permanent meteorological (MET) tower, an aircraft detection lighting system (ADLS) tower, temporary construction laydown areas, a temporary concrete batch plant, an operations and maintenance (O&M) facility, a medium voltage-to-transmission voltage collection substation, a point of interconnection (POI) switchyard, and a short 115kV overhead transmission line that will connect the Facility to the high voltage electrical grid.

### (b) Applicant Information

Hoffman Falls Wind LLC (Hoffman Falls Wind or the Applicant) is a wholly owned subsidiary of Liberty Renewables Inc. (Liberty Renewables) that was formed for the purposes of permitting the Hoffman Falls Wind Project. Liberty Renewables is a renewable energy company based in Albany, NY whose mission is to build, own, and operate wind energy projects throughout New York State.
